Toyo Denki Announces Change to the Operating Officer System and Appointments of Officers

Toyo Denki Seizo K.K. (hereinafter Toyo Denki) today announced that Toyo Denki changed its Operating Officer system and the meeting of the Board of Directors held today officially decided on the following appointments of Operating Officers.

Description

1. Objectives of change to the Operating Officer system

This change separates the supervisory function and the execution function of the Board of Directors for stronger corporate governance. The Board of Directors primarily assumes the role of governance and delegates the execution authority to Operating Officers to further enhance agility of management. Operating Officers shall execute and be responsible for tasks within the range resolved by the Board of Directors under instructions and orders from the President, Representative Director.

- 2. Overview of Toyo Denki's Operating Officer system after the change
 - (1) The number of Operating Officers shall be 20 or fewer.
 - (2) Directors excluding the Chairman of the Board of Directors, the President and Director and the Outside Directors shall be able to assume the role of Operating Officer at the same time.
 - (3) The selection of Operating Officers and Executive Officers (Senior Executive Officers and Executive Officers) shall be proposed by the Nomination and Compensation Advisory Committee under the Board of Directors and decided by the resolution of the Board of Directors. The position of Senior Operating Officer is abolished.
 - (4) The term of office for the Operating Officers shall be one year starting on June 1 and lasting until May 31 of the next year, which is the same as the business year. The Officers shall not be prevented from being reappointed.
