


Net sales by region

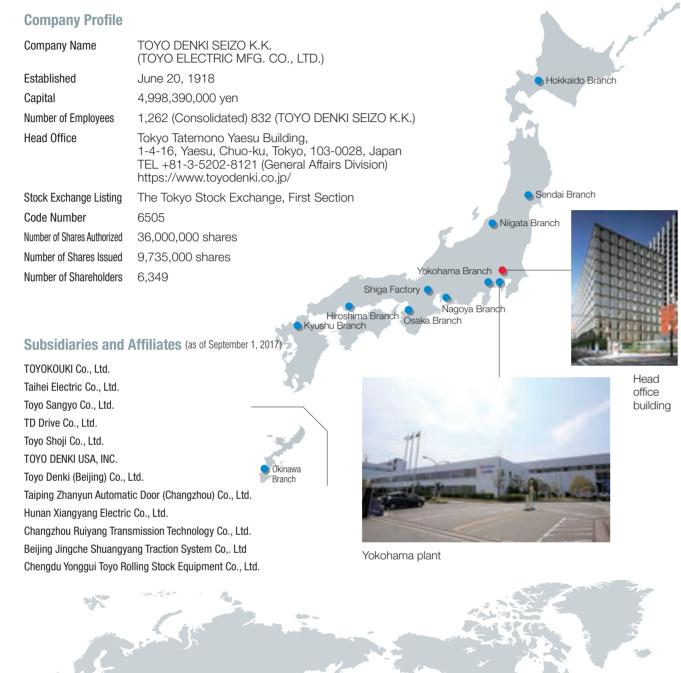

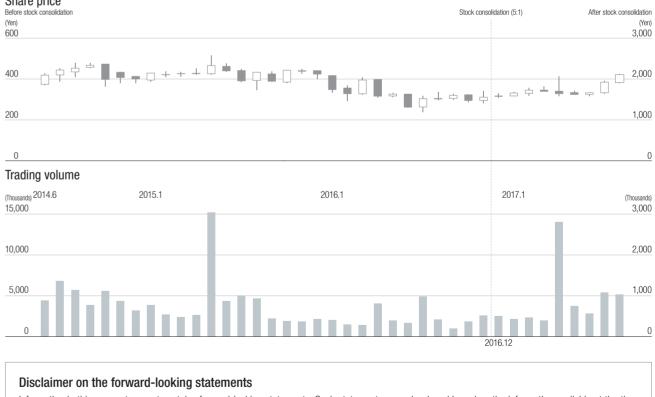

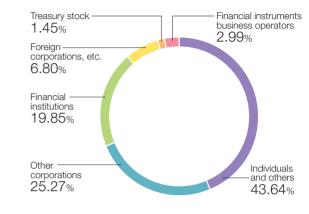
Transition of share price
